1. WHAT ARE COOKIES?

Cookies do not typically contain information that directly identifies you, but they may be linked to other information we collect.

2. TYPES OF COOKIES WE USE

A. Essential Cookies

These cookies cannot be disabled through our cookie preference center because they are necessary to provide the services you request.

B. Functional Cookies

These cookies remember your preferences, including:

Language

Region

Time zone

Saved preferences

Accessibility settings

These cookies improve your experience but are not strictly necessary.

C. Performance Cookies

Performance cookies help us understand how visitors use the Platform.

Examples include:

Most visited pages

Time spent on pages

Navigation patterns

Error messages

Loading performance

These cookies help improve the Platform.

D. Analytics Cookies

We may use analytics providers including:

Google Analytics

Cloudflare Analytics

Internal Analytics Systems

Analytics cookies help us understand:

User behavior

Platform performance

Popular services

Customer experience

Feature usage

Analytics information is generally aggregated and does not directly identify individual users.

E. Security Cookies

Security cookies help us:

Detect fraud

Prevent unauthorized access

Protect user accounts

Monitor suspicious activity

Maintain Platform integrity

These cookies are essential for maintaining a secure marketplace.

F. Preference Cookies

These cookies remember:

Login preferences

Dashboard settings

Favorite providers

Recently viewed services

Search filters

G. Advertising Cookies

Currently, Husband On Demand does not use third-party advertising cookies for behavioral advertising.

If we introduce advertising cookies in the future, we will update this Policy and obtain any required consent under applicable law.

3. SIMILAR TECHNOLOGIES

5. HOW LONG COOKIES REMAIN

Cookies may be:

Session Cookies

Deleted automatically when you close your browser.

Persistent Cookies

Remain on your device until:

They expire;

You delete them;

Your browser removes them.

Expiration periods vary depending on the cookie's purpose.

6. MANAGING COOKIES

You can control cookies through:

Browser settings

Cookie preference tools (if available)

Device settings

You may:

Delete cookies

Block cookies

Receive alerts before cookies are stored

Disable certain categories of cookies

Please note that disabling essential cookies may prevent parts of the Platform from functioning properly.

7. DO NOT TRACK

Some browsers provide a "Do Not Track" ("DNT") setting.

Because there is currently no universally accepted standard for responding to DNT signals, the Platform does not currently respond to DNT requests unless required by applicable law.

8. MOBILE APPLICATIONS

Our mobile applications may use technologies similar to cookies, including:

Device identifiers

Local storage

Push notification tokens

SDK-based analytics

These technologies help provide Platform functionality and improve performance.

9. INTERNATIONAL USERS

If you access the Platform outside the United States, cookies may be subject to local privacy laws, including the General Data Protection Regulation (GDPR) or other applicable regulations.

Where required, we will request your consent before placing non-essential cookies.

10. CALIFORNIA RESIDENTS

California residents may have additional privacy rights under the California Consumer Privacy Act (CCPA), as amended by the California Privacy Rights Act (CPRA).

Information collected through cookies may constitute personal information under California law.
